Doctoring at UC Davis is a longitudinal pass/fail course that runs throughout third year. This small group interactive course asks eight students and two faculty to manage a panel of simulated patients with a focus on doctor-patient communication, ethics, healthcare economics, clinical epidemiology, medical decision making, evidence-based medicine, cultural competency, and other topics not fully addressed in the regular clerkship curriculum. The course allows faculty an ideal opportunity to observe carefully how students interact with each other, with simulated patients, and with their learning assignments.




#### **SUMMARY**
